1. Welcome and Introductions

Troy Lewis, called the meeting to order at 10:10 AM

2. Approval of Minutes

UPON A MOTION by Ms. Dorsey (Nash Co.), second by Ms. Pittman (Edgecombe Co.), the minutes from the UCPRPO TCC meeting held on March 2, 2010 were unanimously approved.

3. TCC Chair and Vice-Chair Election

Mr. Van Liere stated that the election subcommittee asked if the current Chair and Vice-Chair would be willing to serve another term. Upon conversations with the Chair and Vice-Chair it was made clear that they were willing to do so.

UPON A MOTION by Ms. Dorsey (Nash Co.), second by Mr. Bunn (City of Wilson), the nomination of Troy Lewis (Tarboro) for UCPRPO Chair and Fleta Byrd (Wilson's Mills) for Vice-Chair were made and was unanimously approved.

4. 2010-11 Public Work Plan and Five Year Calendar

Mr. Van Liere presented the 2010-11 Planning Work Program (PWP) and Five Year Calendar, explaining that this document serves as the budget for the next Fiscal Year. Mr. Van Liere also explained that this document was nearly identical to the previous year document because of the similarities in projects between the two years. Mr. Van Liere also stated that NCDOT had asked that minor changes be made specifying which counties projects will be done for when stating project details.

UPON A MOTION by Mr. Bunn (City of Wilson), second by Ms. Pittman (Edgecombe Co.), the 2010-11 PWP and Five Year Calendar were unanimously approved for recommendation to the TAC.

Old Business

5. Special Study

Mr. Van Liere gave a brief background on the special study, reminding the TCC that the RPO has hired a part time position to work on the special study. Mr. Van Liere reminded the group that he had presented the economic development website at the previous meeting and that he and the UCPRPO staff were continuing to work on the site in an effort to improve its usability and functionality. Mr. Van Liere stated that Mr. Lewis (Division 4) had mentioned future functionality of finding demographics based on a drive time from a location



and that the RPO staff had been able to develop that functionality as requested. The go live date for the site will be May 17^{th} .

6. UCPRPO Website

Mr. Van Liere stated that he is continuously updating the website and asked that members continue to use the site and make recommendations for any changes members would like to see made.
