Thank you for contacting me regarding transportation issues and Rural Planning Organizations (RPOs). It was good to hear from you, and I appreciate your taking the time to share your views with me.

In response to your request, I have cosponsored Congressman Walz's bill, H.R. 2782. This bill would incorporate regional transportation planning organizations into statewide transportation planning. Congress must take action soon, as the current authorization, known as SAFETEA-LU, expires on September 30, 2009.
