#### Introduction

- Welcome & Introductions Lu Harvey Lewis TAC Chair TAC Chair Mr. Lu Harvey Lewis (Middlesex) called the meeting to order. Mr. Lewis welcomed and thanked everyone for attending the meeting.
- 2. Mr. Lu Harvey Lewis asked if any members have a conflict of interest on any of the items on the agenda. There being none.
- 3. Agenda Approval Mr. Lu Harvey Lewis asked if everyone had an opportunity to review the agenda and if there were any proposed changes. There were no changes requested. UPON A MOTION by C.B. Brown (Tarboro), second by Miranda Boykin (Sims) the agenda was unanimously approved.
- Minutes September 22, 2021
   After reviewing the Minutes for the September 22, 2021 meeting and UPON A MOTION by C.B. Brown (Tarboro), second by Miranda Boykin (Sims) they minutes for September 22, 2021 TAC meeting was unanimously approved.

#### **Action Items**

- 5. Resolution to Reallocate FY22 CMAQ Unused Funds to the Town of Tarboro Members were informed that the Town of Selma had decided not to proceed with their FY22 CMAQ project allocated last year by the TAC. Members were provided a brief overview of the previous FY19 Tarboro project. At their regular meeting on January 4, 2022, the TCC recommended to the TAC that the FY22 CMAQ funds be reallocated to the Town of Tarboro to help with the completion of their previous FY19 CMAQ project. After a brief discussion and UPON A MOTION by C.B. Brown (Tarboro), second by Miranda Boykin (Sims) the Resolution to reallocate the FY22 CMAQ funds from the Town of Selma to the Town of Tarboro was unanimously adopted.
- 6. Resolution to Allocate FY23 CMAQ Funds to the Town of Tarboro A brief review of the proposed Town of Tarboro CMAQ project was provided. The project consisted of constructing a pedestrian sidewalk 4,600' long along Western Blvd from W Howard Ave to W St James St. After a brief discussion and UPON A MOTION by Ted Godwin (Johnston), second by Wayne Outlaw (Nash) the Resolution to allocate the FY23 CMAQ funds in the amount of \$603,240.00 to the Town of Tarboro was unanimously adopted.

# UPPER COASTAL PLAIN RURAL PLANNING ORGANIZATION

7. Election of new TAC Chair and Vice Chair

Chair Lu Harvey Lewis (Middlesex) opened the nominations for Chair. **UPON A MOTION** by Lu Harvey Lewis (Middlesex) and seconded by Ted Godwin (Johnston), C.B. Brown (Tarboro) was nominated and elected to be Chair of the TAC. Chair Lu Harvey Lewis declared C.B. Brown as chair by proclamation with no vote due to there being no other nominations for chair. Chair Lu Harvey Lewis then opened the floor for Vice Chair. **UPON A MOTION** by Ted Godwin (Johnston) and a second by Wayne Outlaw (Nash) Miranda Boykin (Sims) was nominated for Vice Chair. There being no additional nominations Chair Lu Harvey Lewis declared Miranda Boykin Vice Chair by proclamation with no vote.

#### Discussion

8. Prioritization P6 Update – STI Project Scores Released

Members were provided with a list of all UCPRPO P6 project scores released on November 12, 2021. Everyone was reminded that P6 has been halted and that the scores were for informational purposes only. There would be no local input points will be assigned. Ultimately over 2,300 projects in all six modes were scored. Members were then provided with the most recent P6 schedule. It was reported that the STI Workgroup was working through developing a process to allow some flexibility in reprogramming projects. Training for Divisions and MPOs/RPOs is expected within the next couple of months. The final STIP is expected to be adopted by the Board of Transportation by summer 2023. NCDOT expects to have a draft STIP developed by April or May 2022.

- 9. Review of Draft Public Participation Plan (PPP) The draft UCPRPO Public Participation Plan (PPP) was provided to all members in the agenda packet. The PPP provides a guidance and policy in engaging the public in the transportation process. Members were asked to provided comments by February 15, 2022, so any modifications could be applied prior to the March 2, 2022 TCC meeting when the TCC will be asked to adopt the plan for recommendation to the TAC for adoption.
- 10. Review of Draft Planning Work Program (PWP) The UCPRPO adopts their Planning Work Program (PWP) annually. A draft PWP and local 20% match requirement was provided in the agenda packet. The amount allocated to the UCPRPO for FY23 is \$140,048.00. Members were asked to review and provide any comments by February 1<sup>st</sup>. The final version will be presented to the TCC for consideration for approval to recommend adoption by the TAC at the March meeting.
- 11. Neuse River Trail Clayton to Smithfield Feasibility Study Update

The John R McAdams was the selected consultant to help complete the Neuse River Trail Clayton to Smithfield Study. The Core Stakeholder Workgroup held their initial kick off meeting on December 1, 2021. The project team will be reaching out for public input and performing property owner interviews in the coming months. The team completed one field visit along Buffalo Rd as one option for the trail The next field visit is scheduled for January 7, 2022 and members were invited to join the team. It was reported that the NC Budget includes \$29.24M for development of trails designated as NC State Parks Trails and that this project may be a good candidate for funding. It was reported that the Nash County Board of Commissioners passed a resolution of support for the Triangle Trails Initiative.

#### 12. US 264 Receives Interstate Designation as I-587

It was reported that the US 264 highway between the City of Wilson and Greenville has received the I-587 Interstate designation.



#### Reports

13. US 70 Commission

The US 70 Commission met on December 9, 2021 virtually. NCDOT Board Member Melvin provided an update on the newly opened CCX Terminal Facility. The State Chief Engineer gave a brief update on funding bills recently passed by the State and US Congress. Both Division 2 and Division 4 provided updates on all the projects along the corridor. The US 70 Commission passed a resolution of support for NCDOT to fund the I-42 projects in Princeton and Kinston. Project R-5829B in Princeton is within the UCPRPO and is currently in the STIP but may be delayed due to over programming with R/W to begin 2025. The project includes GARVEE Bond Funding.

- 14. Hwy 17/64 Association
  - There was no report at this time.
- 15. Legislative Update

An update was provided on the recently passed NC State Budget and the Federal Infrastructure Investment and Jobs Act (IIJA) or Bipartisan Infrastructure Deal (BID).

- *16. NCDOT Division 4* There was no Division 4 update.
- 17. NCDOT Planning Division (TPD)

Carlos Moya (TPD) provided the TPD January 2022 newsletter to all members. He reported that NCDOT was awarded the National Safety Award with their effort to place high-visibility markings that have resulting in a 13% reduction in lane departure crashes. The NCDOT is also working new Integrated Project Delivery to help maximize efficiency in delivering projects. In addition, the Department is working on climate change and population growth resiliency plans to help better the State of North Carolina position itself in dealing with ongoing changes in the climate.

Advancing Clean Energy for a Sustainable Economy

NC Clean Energy Technology Center is Exploring Creating a Clean Cities Coalition for Unrepresented Regions of North Carolina



## What are Clean Cities Coalitions?

The Clean Cities Coalitions were originally created by the U.S. Department of Energy in order to reduce reliance on petroleum products and improve air quality. Clean Cities coalitions do this by convening partnerships of public and private stakeholders to share information and resources regarding alternative fuels and advanced vehicle technologies that reduce fuel use and related air pollution.

Why is there a need for a fourth Clean Cities Coalition in North Carolina?

Large swaths of North Carolina are currently unrepresented by Clean Cities Coalitions. These areas have less access to the support services offered by Clean Cities Coalitions. North Carolina (NC) has three Clean Cities Coalitions, represented by three Regional Councils of Governments, representing 44% of NC's population, around the Asheville, Charlotte, and Raleigh-Durham metro areas. The North Carolina Clean Energy Technology Center (NCCETC) is seeking partners to form an additional Clean Cities Coalition to provide alternative fuel initiatives to rural and underserved communities in the Eastern, Northeastern, and Central regions and will reach an additional 45% of North Carolina's population.

# **Background on the NC Clean Energy Technology Center**


The NC Clean Energy Technology Center is located on North Carolina State University's (NCSU) campus in the College of Engineering, and is one of two land-grant universities in North Carolina. NCSU's Cooperative Extension offices operate in all 100 counties in North Carolina, providing resources and training to the public on topics such as agriculture and natural resource management. NCCETC's mission is to advance a sustainable energy economy by educating, demonstrating, and providing support for clean energy technologies, practices, and policies. NCCETC has over 30 years of experience in forming partnerships and providing technical assistance with industries, academia, governments, profit, and nonprofit organizations. NCCETC already manages education and outreach activities related to clean transportation, such as the annual Sustainable Fleet Technology Conference & Expo, alternative fuel vehicle demonstrations and ride and drives, and online webinars on topics related to sustainable fleet management.

# How can my organization be involved?



By joining our coalition as a stakeholder, you will be supporting the clean fleets, alternative fuels, and sustainable transportation across North Carolina. As a fleet, you have access to resources that will provide guidance on ways that you can improve the efficiency and sustainability of your vehicles. As a manufacturer or trade organization, you will have access to a network of partners and organizations that are expanding their infrastructure and fleets. Our staff can also provide assistance by providing advice on available technologies and available grant funds that can be applied for to help offset the costs of installing new technologies. There will be quarterly stakeholder meetings that you can attend in person or virtually to learn more about these technologies and network with others in your region who are also working to improve the sustainability of their vehicle fleets.



# Clean Fuels and Advanced Technology (CFAT) Project

- The CFAT project deploys federal Congestion Mitigation Air Quality (CMAQ) funding received from the N.C. Department of Transportation (DOT)
- Those funds provide direct financial assistance to numerous clean transportation projects each year for a variety of public and private entities, all focused on reducing transportation-related air pollution emissions
- The funds focus on 24 CMAQ-eligible counties currently in "maintenance" status under federal air quality rules, though electric charging infrastructure can be funded statewide
- NC CLEAN ENERGY TECHNOLOGY CENTER

 We are awaiting our contract for these funds and hope to put out an RFP in the late Winter/ early Spring.



# **CFAT Project Overview Cont'd**

 Over past 15 years, we have provided \$11.9M in federal funds to help private and public fleets in NC purchase clean transportation technologies to improve NC air quality Some projects funded to date:

- 110 Infrastructure projects
- 327 Alternative fuel vehicles
- 39 Hybrid vehicles
- 74 Diesel retrofits
- 128 Propane retrofits
- 310 Telematics units

#### **RE:** Support for a new Eastern and Central NC Clean Fuels Coalition

To whom it may concern:

We, the Upper Coastal Plain Rural Transportation Planning Organization (UCPRPO), are writing in support of the formation of an additional Clean Cities Coalition in North Carolina, serving currently unserved regions in eastern, northeastern, and central North Carolina. Our organizations are joining as stakeholders of the Eastern and Central North Carolina Clean Fuels Coalition, led by the NC Clean Energy Technology Center (NCCETC), part of the College of Engineering at NC State University.

The NC Clean Energy Technology Center is uniquely situated to lead a new Clean Cities coalition. NCCETC is recognized as one of the premier providers of technical assistance and education on the topic of clean transportation technologies in the Southeast. The Sustainable Fleet Technology conference and webinar series has provided in-depth information on topics related to sustainable transportation and convened industry experts, fleet managers, and other decision-makers to share information on best practices in sustainable fleet management. As part of NC State University, NCCETC is also able to leverage the resources of the university, including the extension offices located in every North Carolina county.

The NC Clean Energy Technology Center has administered the Clean Fuels Advanced Technology (CFAT) grant since 2006. The purpose of the project is to reduce transportation related emissions in NC that cause air quality concerns. Using these funds, NCCETC has organized trainings and other educational efforts around alternative fuels, as well as providing grants for the purchase of clean transportation technologies. As of 2020, this project has awarded over \$11.9 M in federal funding to private and public fleets throughout the state and helped them purchase technologies to improve NC air quality. NCCETC has partnered with the Piedmont Triad Regional Council, Kerr Tar Council of Governments, and the Upper Coastal Plains Council of Governments to provide trainings in their regions on alternative fuels and clean transportation technologies.

North Carolina currently has three Clean Cities Coalitions, representing 44% of NC's population, around the Asheville, Charlotte, and Raleigh-Durham metropolitan areas. The creation of a fourth coalition, representing the eastern and northeastern counties of the state and the central Piedmont Triad region, would greatly increase the percentage of the population represented by a Clean Cities coalition and increase the number of rural and historically underrepresented counties served by a Clean Cities coalition. Currently 79 of North Carolina's 100 counties are not represented. Representation through a Clean Cities coalition is imperative for applying for certain federal funds. Clean Cities coalitions also provide valuable educational opportunities to stakeholders in their regions through technical assistance, trainings, and workshops. Expanding the geographic areas



represented by a Clean Cities coalition in North Carolina will help to re- duce the state's dependence on foreign oil, reduce transportation related emissions, and im- prove public health.

Therefore, we believe the Eastern and Central North Carolina Clean Fuels Coalition will benefit rural and underserved communities within the central, eastern, and northeastern regions of North Carolina and we look forward to working together with the NC Clean Energy Technology Center a stakeholder in a new coalition to reduce transportation emissions, improve resilience in the face of climate change, and improve the sustainability of our transportation system.



## **Purpose**

Public involvement is a very important component of the rural planning organization input and decisionmaking processes. Public involvement is synonymous with the term "public participation." It is specifically identified in the enabling state legislation (NCGS 136-212) as being among the core duties and responsibilities of rural planning organizations in North Carolina. It is also recognized as a necessary element of the transportation planning process in major federal surface transportation legislation and regulations. This federal legislation includes the 2012 Moving Ahead for Progress in the 21<sup>st</sup> Century Act (MAP-21), the Americans with Disabilities Act of 1990 and the Clean Air Act Amendments of 1990. Public involvement has also been recognized in a 1997 federal executive order pertaining to environmental justice assurances. These assurances protect low-income and minority populations from bearing disproportionate impacts resulting from transportation decisions. Effective public involvement will promote sound decision making and will support the achievement of desirable rural transportation planning goals.

The purpose of the Upper Coastal Plain Rural Transportation Planning Organization (RPO) Public Involvement Plan (Plan) is to provide guidance and policy in engaging the public in the transportation planning process. The Plan has the following objectives:

- 1. Create a well-informed public that contributes to transportation decision-making in a meaningful way
- 2. Engage the public early and continuously in the transportation planning process
- 3. Develop a public education program on Upper Coastal Plain RPO activities
- 4. Assist the Upper Coastal Plain RPO in developing specific transportation projects that reflect the interests and needs of the community
- 5. Gain the support and trust of the public
- 6. Satisfy the requirements of N.C.G.S. § 136-212 regarding duties of a RPO

The Plan is not intended to preempt any public involvement activities conducted by the North Carolina Department of Transportation (NCDOT) or any local governments within the Upper Coastal Plain RPO region.

## **Forms of Public Involvement**

## A. Public Outreach

Public Outreach is the process of informing the public about the transportation planning process, specific transportation projects, and activities of the Upper Coastal Plain RPO. Typical public outreach strategies include, but will not be limited to, the following: Open RTCC and RTAC meetings, development of an RPO web site, newsletters, press releases, open houses, and presentations to civic organizations and other interested groups.

One or more of the following specific measures will be used, as appropriate, to meet the needs of the public, the RPO, and NCDOT for a given transportation plan, project, or program:

#### **Notification of Meetings**

Notification of Upper Coastal Plain RPO meetings will be posted on the UCPRPO website and may be sent to news media in the region. These notifications will generally be made by electronic means, although other methods may be used as appropriate. UCPRPO staff will maintain an email list for this purpose and will add to the list any media outlet that requests addition. Additionally, UCPRPO staff will provide electronic notification to citizens/stakeholders who request to receive these notifications, or who provide contact information to UCPRPO.

#### **Posting of Draft and final Planning Documents**

Copies of draft and final versions of certain planning documents will be posted on the Upper Coastal Plain RPO's website, and may be distributed to Upper Coastal Plain RPO member governments for posting on individual county and town websites.

Copies of draft and final versions of certain planning documents will also be made available for public review on the Upper Coastal Plain RPO's website.

#### **Press Releases**

The Upper Coastal Plain RPO may issue press releases from time-to-time detailing significant actions of the RPO. These actions may include:

- 1. Adoption of Long-Range Regional Transportation Plan
- 2. Adoption of Highway Project Priority List
- 3. Adoption of Significant Planning Policies and/or Documents

#### **Open Houses**

Open houses may be held to provide information on transportation projects and Upper Coastal Plain RPO activities to the public in an informal setting. Open houses will have no fixed agendas or formal presentations. Planning documents, project maps, and other transportation-related information will be displayed. RPO staff and committee members will be available to provide details and answer questions.

#### **Presentations to Civic Organizations**

Presentations will be made to interested civic organizations on Upper Coastal Plain RPO activities, the transportation planning process in general, or specific transportation projects upon request. Presentations will be made by Upper Coastal Plain RPO staff and/or NCDOT staff.

Public Outreach activities will include efforts to involve traditionally underserved groups (i.e., minorities, elderly, low-income persons) in the transportation planning process. These efforts may include, but not be limited to, the following:

- 1. Identifying areas in the Upper Coastal Plain RPO region with concentrations of minority, elderly, and low-income populations
- 2. Sending notification of meetings, public hearings, and open houses to County Health Departments, Senior Centers, and/or Community Centers for posting
- 3. Publishing notification of meetings, public hearings, and open houses in both English and Spanish when feasible

#### **UCPRPO Website**

UCPRPO will maintain a website to serve as a primary method for sharing information with the public. The website will contain, at minimum (but not limited to):

- RTCC & RTAC meeting agendas and minutes
- A roster of current RTCC & RTAC members
- Information on Comprehensive Transportation Plans
- Information on project selection and prioritization for the Strategic Transportation Investments (STI) process
- Contact information

The website (<u>www.ucprpo.org</u>) may also include other materials, as needed, to help the public understand the plans and activities underway by UCPRPO and its local/state partners.

#### **B.** Public Input

Public Input is the process of gathering the views, opinions, and ideas of interested individuals and groups in the transportation planning process. Opportunities for public input provided by the Upper Coastal Plain RPO may include, but are not limited to, the following:

#### **Public Comment at Upper Coastal Plain RPO Meetings**

Upper Coastal Plain RPO meetings are open to the public and provide opportunity for public comment. The UCPRPO will offer virtual meeting capabilities when available.

#### **Public Hearings**

Public hearings will be held by the Upper Coastal Plain RPO's Rural Advisory Committee (RTAC) prior to taking formal action on specific planning documents. These actions may include:

- 1. Endorsement of Long Range Regional Transportation Plan
- 2. Amendment to Long-Range Regional Transportation Plan
- 3. Adoption of TIP Candidate Highway Project Priority List

#### **Open Houses**

Open houses will be held to provide information on transportation projects to the public in an informal setting. The open houses also provide the public an opportunity to provide comments. Open houses will have no fixed agendas or formal presentations. Planning documents, project maps, and other transportation-related information will be displayed. RPO staff and committee members and/or NCDOT staff will be available to provide details and answer questions.

#### **Surveys**

Surveys may be developed to gauge citizen opinion on specific transportation planning issues and/or projects. Survey content, method of distribution, and geographic target area will be dependent on the specific transportation planning issue or project.

#### Workshops

Workshops will be in the form of small group discussions used to gather views and opinions on a single transportation topic or project. The workshops will provide detailed information on the specific issue and will allow for in-depth discussion by invited key stakeholders, local government officials, and citizens.

### **Schedule of Public Involvement**

### A. Regular Public Involvement Opportunities

#### **Planning Documents**

All documents, resolutions, meeting minutes, etc. adopted by the Upper Coastal Plain RPO are kept at the Upper Coastal Plain RPO office located within the Nash County office building at 120 W. Washington St. Suite 2110, Nashville, NC. These documents will be made available for public review upon request.

#### Meetings

Regular meetings of the Upper Coastal Plain RPO's Rural Transportation Coordinating Committee (RTCC) and Rural Transportation Advisory Committee (RTAC) are open to the public. A timely opportunity for public comment on the Draft STI Candidate Project Priority List and the Long Range Regional Transportation Plan will be made available at one RTCC and one RTAC meeting. Notification of the meetings will be posted on the UCPRPO's website.

#### **Public Hearings**

Public hearings will be scheduled by the UCPRPO RTAC and staff prior to taking formal action on certain planning documents. Notification of all public hearings held by the Upper Coastal Plain RPO may be sent to news media in the region and will posted on the UCPRPO website. Public hearings will typically be held at the beginning of a regular RTAC meeting but may also be held as standalone meetings if deemed appropriate by the RTAC. Public hearings will consist of a presentation followed by a period for formal public comments and questions. All comments and questions that are received will become public record and will be considered by the RTAC.

#### **Press Releases**

Press releases issued by Upper Coastal Plain RPO may be sent to news media within the region.

## **B. Public Involvement for Specific Activities**

Public involvement strategies will vary depending on the particular issue or project for which public comment is desired. Typical actions for specific activities of the Upper Coastal Plain RPO may include, but are not limited to:

#### **Comprehensive Transportation Plan (CTP)**

- Workshops
- Regular Meetings of RTCC and RTAC
- Public Hearing
- Posting of Draft and Final Document
- Presentations to Civic Organizations

## Prioritization of Projects for Recommendation to North Carolina's Transportation Improvement Plan (TIP)

- Regular Meetings of RTCC and RTAC
- Posting of Draft and Final Document on UCPRPO website

#### **Specific Projects/ Issues**

- Press Releases
- Workshops
- Regular Meetings of RTCC and RTAC
- Presentations to Civic Organizations
- Surveys

## C. Outreach to Environmental Justice/Title VI Communities

Public outreach activities will also include efforts to involve traditionally-underserved groups—including minority, elderly, disabled, and low-income persons—in the transportation planning process. These efforts will include, but not be limited to, the following:

- Identifying communities and other areas in the TARPO region with concentrations of underserved populations, based on the mapping of available Census and American Community Survey data including organizations that deal directly with underserved communities on project/plan stakeholder lists or email lists
- Posting notifications of meetings and events in the County Senior Citizen Centers 

   Ensuring that TARPO meetings are held in ADA-accessible facilities and that reasonable accommodations are made for hearing-impaired and visually impaired persons to participate in TARPO activities (with advance notice)
- Ensure that TARPO activities follow Title VI requirements with regard to Limited English Proficiency
- In addition, the UCPRPO will follow the public involvement guidelines in Appendix B.

## **Response to Public Input**

Public involvement may be documented in a variety of ways. Comments received during a meeting of the Upper Coastal Plain RPO's RTCC or RTAC will be included in the meeting minutes. Also, any comments received during a public hearing held by the Upper Coastal Plain RPO's RTAC will be included in the meeting minutes. Written comments received during workshops, open houses, or presentations to civic organizations will be presented to the RTCC and RTAC, and kept on file. Results of surveys will be compiled, summarized, presented to the RTCC and RTAC, and kept on file.

Significant public comments may be included as appendices in formal documents or plans for which they were made.

## **Appendix B: Title VI Public Involvement**

Effective public involvement is a key element in addressing Title VI in decision-making. This **Public Participation Plan** describes how Upper Coastal Plain Rural Planning Organization (UCPRPO) will disseminate vital agency information and engage the public. We will seek out and consider the input and needs of interested parties and groups traditionally underserved by transportation systems who may face challenges accessing our services, such as minority and limited English proficient (LEP) persons. Underlying these efforts is our commitment to determining the most effective outreach methods for a given project or population.

General public involvement practices will include:

- Expanding traditional outreach methods. Think outside the box: Go to hair salons, barbershops, street fairs, etc.
- Providing for early, frequent and continuous engagement by the public.
- Use of social media and other resources as a way to gain public involvement.
- Coordinating with community- and faith-based organizations such as the Hispanic Liaison, educational institutions, and other entities to implement public engagement strategies that reach out specifically to members of affected minority and/or LEP communities.
- Providing opportunities for public participation through means other than written communication, such as personal interviews or use of audio or video recording devices to capture oral comments.
- Considering radio, television, or newspaper ads on stations and in publications that serve LEP populations. Outreach to LEP persons could also include audio programming available on podcasts.

#### **PUBLIC NOTIFICATION**

We will inform people of their rights under Title VI and related authorities with regard to our program. The primary means of achieving this will be posting and disseminating the policy statement and notice. Additional measures may include verbally announcing our obligations and the public's rights at meetings, placing flyers at places frequented by targeted populations, and an equal opportunity tag-on at the end of radio announcements. The method of notification will be determined through an initial screening of the area.

#### **DISSEMINATION OF INFORMATION**

Information on Title VI and other programs will be crafted and disseminated to employees, contractors and subrecipients, stakeholders, and the general public. Public dissemination efforts may vary depending on factors present, but will generally include: posting public statements setting forth our nondiscrimination policy in eye-catching designs and locations; placing brochures in public places, such as government offices, transit facilities, and libraries; having nondiscrimination language within contracts; including nondiscrimination notices in meeting announcements and handouts; and displaying our Notice of Nondiscrimination at all our public meetings. At a minimum, nondiscrimination information will be disseminated on our website and on posters in conspicuous areas at our office(s). Project-related information and our most current Title VI-related information will be maintained online.

#### MEETINGS AND OUTREACH

There is no one-size-fits-all approach to public involvement. A variety of comprehensive and targeted public participation methods will be used to facilitate meaningful public involvement. Methods for engaging stakeholders and target audiences, including traditionally underserved and excluded populations (i.e., minorities, youth, low-income, the disabled, etc.) will include the following:

#### Public Relations and Outreach

Public relations and outreach (PRO) strategies aim to conduct well-planned, inclusive, and meaningful public participation events that foster good relations and mutual trust through shared decision-making with the communities we serve.

- We will seek out and facilitate the involvement of those potentially affected.
- Public events will aim to be collaborative, fun, and educational for all, rather than confrontational and prescriptive.
- Media plans will typically involve multiple channels of communication like mailings, radio, TV, and newspaper ads.
- Abstract objectives will be avoided in meeting announcements. Specific "attention-grabbing" reasons to attend will be used, such as "Help us figure out how to relieve congestion on [corridor name]" or "How much should it cost to ride the bus? Let us know on [date]."
- Efforts will be made to show how the input of participants can, or did, influence final decisions.
- We will do our best to form decision-making committees that look like and relate to the populations we serve.
- We will seek out and identify community contacts and partner with local community- and faithbased organizations that can represent, and help us disseminate information to, target constituencies.
- Demographic data will be requested during public meetings, surveys, and from community contacts and committee members.

#### Public Meetings

"Public meeting" refers to any meeting open to the public, such as hearings, charrettes, open house and board meetings.

- Public meetings will be conducted at times, locations, and facilities that are convenient and accessible.
- Meeting materials will be available in a variety of predetermined formats to serve diverse audiences.
- An assortment of advertising means may be employed to inform the community of public meetings.

• Assistance to persons with disabilities or limited English proficiency will be provided, as required.

#### Small Group Meetings

A small group meeting is a targeted measure where a meeting is held with a specific group, usually at their request or consent. These are often closed meetings, as they will typically occur on private property at the owner's request.

- If it is determined that a targeted group has not been afforded adequate opportunities to participate, the group will be contacted to inquire about possible participation methods, including a group meeting with them individually.
- Unless unusual circumstances or safety concerns exist, hold the meeting at a location of the target group's choosing.
- Share facilitation duties or relinquish them to members of the target group.
- Small group discussion formats may be integrated into larger group public meetings and workshops. When this occurs, the smaller groups will be as diverse as the participants in the room.

#### **Community Surveying**

- Opinion surveys will occasionally be used to obtain input from targeted groups or the general public on their transportation needs, the quality or costs of our services, and feedback on our public outreach efforts.
- Surveys may be conducted via telephone, door-to-door canvassing, at community fairs, by placing drop boxes in ideal locations, or with assistance from other local agencies like social services.
- Surveys will be translated into languages other than English, when appropriate.

North Carolina's <u>bicycle route system</u> was developed in response to the 1974 Bicycle and Bikeway Act. The system was created on roads across North Carolina that were safer for bicycling, designating a network of "bicycling highways" that provided access to small towns, state parks, historic sites and other points of interest. These routes generally parallel the major highways along which cyclists often wish to travel but offer a more lightly traveled alternative than the busy, major roads that are familiar to most people.

Given the extensive development that has occurred across North Carolina since the 1970's and associated changes to the roadway network, the N.C. Department of Transportation recognized the need to re-evaluate and update the state bike route system in 2013, as part of the statewide bicycle and pedestrian plan, called <u>WalkBikeNC</u>.

NCDOT is now initiating another update to the route system, based on a more current review of existing and planned bicycle facilities throughout the state. The public is invited to help identify additional potential changes to the system, based on recent roadway projects, local planning, and local knowledge and understanding of the routes. To provide input, please visit the <u>NCDOT State Bike Route System Public Input Map</u>. Input will be accepted until March 14, 2022.







#### Memorandum to: Upper Coastal Plain Rural Planning Organization Transportation Advisory Members

#### **RE: Required Ethics Filing for FY22**

NCGS 136-211 requires all local members (and alternates) of an MPO or RPO Transportation Advisory Committee (TAC) to file both a Statement of Economic Interest and a Real Estate Disclosure with the State Ethics Commission. These must be filed before a person can take a seat on the TAC, and then thereafter annually by April 15 each year. This requirement only applies to TAC members and alternates, not to TCC members.

The easiest way for RTAC members to file is online at <u>https://ethics.nc.gov/seis/electronic-filing</u>. If a returning member does not have any changes in their information, they may be able to file an abbreviated "short form." When you file electronically, be sure to use this link for the MPO/RPO filers, since the forms for MPO/RPO filers are slightly different from those used by other filers. Also be sure to check the box saying that you are filing for the Upper Coastal Plain Rural Planning Organization TAC.
